

Special Meeting Shell Rock City Council
April 22, 2025

Mayor Mike Klinefelter called April 22, 2025, special session of the Shell Rock City Council to order at 5:00 pm in the Council Chambers at 802 N Public Road, Shell Rock, Iowa with the Pledge of Allegiance. Councilors present: David Beenen, Mark Berglund, Adam Fox, Jared Krull, and Garrett Schuldt. Others present: Mike Tellinghuisen, Jessica Meyer, Karen Peterson, Jim Gates.

Motion by Beenen seconded by Fox to approve the agenda. Ayes- Fox, Berglund, Krull, Beenen, and Schuldt. Nays-None. Motion carried 5:0.

Mayor Klinefelter opened the Public Hearing at 5:01 pm for purpose of public comment on the proposed budget for the City of Shell Rock, Iowa starting July 1, 2025, and ending June 30, 2026, as published. Motion carried 5:0. Resolution 010-2025 was introduced by Beenen seconded by Fox: A RESOLUTION APPROVING THE SLFRF REPORT. Ayes- Fox, Berglund, Krull, Beenen, and Schuldt. Nays-None. Motion carried 5:0.

Motion Berglund seconded by Schuldt to approve Library Board Trustee registration from Julie Gibson. Ayes- Fox, Berglund, Krull, Beenen, and Schuldt. Nays-None. Motion carried 5:0.

Discussion was held concerning stop sign placement in Reints Addition.

Motion Krull seconded by Beenen to approve Swing Show to store swing show music and items at City Hall. Ayes- Fox, Berglund, Krull, Beenen, and Schuldt. Nays-None. Motion carried 5:0.
